- Antas ng Kakayahan sa Wikang Hapon: Kailangang kumpirmahin sa pamamagitan ng mga pagsusulit upang malaman ang kakayahan sa wikang Hapon na kakailanganin sa araw-araw na pamumuhay at trabaho (Ang nakatapos ng Technical Intern Training (ii) ay hindi na kailangang kumuha ng mga pagsusulit, atbp.)
- Pagsama ng pamilya: Hindi maaari
- Maaaring makatanggap ng suporta mula sa Accepting Organizations o Registered Support Organizations
